**S.R.O.No.393/2009** -- In exercise of the powers conferred by section 9 of the Legal Services Authorities Act, 1987 (Central Act 39 of 1987), read with rule 9 of the Kerala State Legal Services Authorities Rules, 1998 and in consultation with the Chief Justice of the High Court of Kerala as required by the said section and in supersession of the previous notification issued as No.8168/H1/2001/Law dated 28<sup>th</sup> January 2005, and published as S.R.O.No.82/2005 in the Kerala Gazette Extraordinary No.194 dated the 29<sup>th</sup> January 2005, the Government of Kerala hereby re-constitute the District Legal Services Authority for the following Districts in the State, consisting of the members detailed below, namely:-
